

TERMS AND CONDITIONS — BUDDY AGENT

1. Introduction

Welcome to HowMy.co.in (“Company”, “We”, “Us”, “Our”).

- As a registered Buddy Agent, you agree to perform assigned plot monitoring tasks ethically, accurately, and as per the Company’s policies.
- These Terms govern your relationship with HowMy while performing assignments.

2. Scope of Work

- Buddies are responsible for visiting assigned plots, capturing clear photos and/or videos, and uploading them within the given time.
- Talk to owners to capture geo coordinates of the owner’s property and save the information to HowMy website.
- All work must be performed accurately, honestly, and within the guidelines provided by the Company.
- If there are issues or dissatisfaction from owners or our company with the work done by you, you are liable to do rework of the same assignment and complete it to meet expectations.
- You are not an employee of the Company; you act as an independent field partner on assignment basis.

3. Accuracy and Integrity

- Every assignment must reflect real and authentic data.
- If any cheating, falsification, or misuse of data is detected, your account will be immediately deactivated, and no further assignments will be given.
- Legal action may be taken if fraud results in financial or reputational loss to the Company or its clients.

4. Professional Conduct

- You must maintain professional and respectful behaviour at all times during assignments.
- You should avoid arguments or quarrels with property owners, neighbours, or any third parties while on-site during your assignments.

5. Ethical Obligations

- Do not share client information, photos, or videos outside the HowMy Platform.
- Do not misuse, edit, or sell data captured for personal or third-party gain.
- Treat all client information as strictly confidential.

6. Liability for Misconduct

- Any damage to the Company's reputation, brand, or property resulting from your behaviour or negligence will make you personally liable for all resulting losses.
- The Company reserves the right to recover damages, terminate your account, or initiate legal action as needed.

7. Payment Terms

- Payments for assignments will be made after successful completion and verification of your work by HowMy admin.
- If any discrepancies, fake submissions, or misconduct are found, payments for that assignment will be withheld.
- Continued violations will lead to permanent termination of your profile.

8. Termination

- The Company may terminate your registration as a Buddy without prior notice if:
- You violate these Terms, Engage in fraudulent or unethical behaviour, or Cause harm or loss to clients or the Company.

9. Independent Contractor Status


- Buddies are independent service providers, not employees of the Company.
- They are responsible for their own taxes, safety, and travel expenses during assignments.
